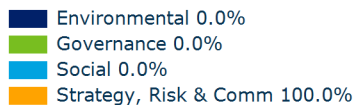

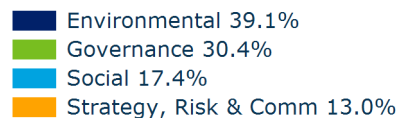

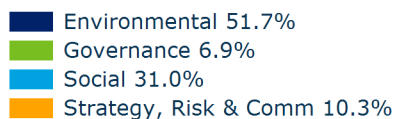

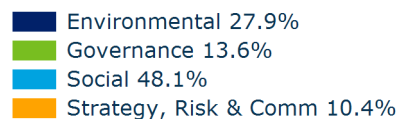

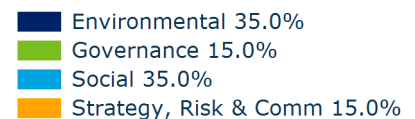

Environmental topics featured in 32.6% of our engagements



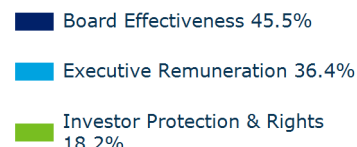
### Social

Social topics featured in 41.4% of our engagements



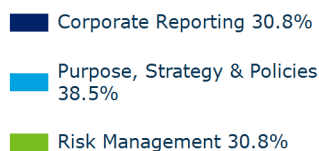
### Governance
