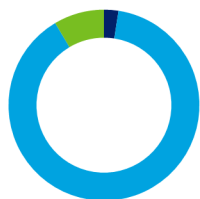

Environmental topics featured in 41.8% of our engagements



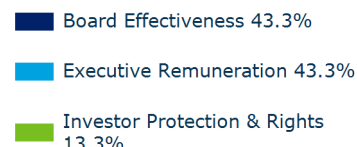
### Social
