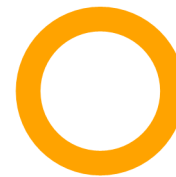

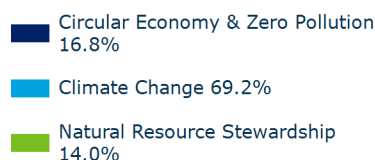

Environmental topics featured in 45.5% of our engagements



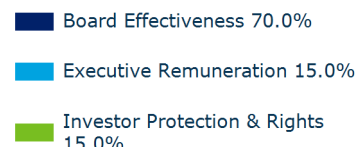
### Social
